SESSIONS

Sessions will be 1 1/4 hours or 2 1/2 hours in length. Rooms will be set either classroom or theater style.

CONFLICT OF INTEREST

A conflict of interest is considered to exist if the Speaker has a financial interest in or is affiliated with a commercial organization that may have a direct or indirect interest in the subject matter of the program. Speakers must disclose any such conflict of interest to ACA Southeastern in writing prior to or contemporaneous with submitting the proposal. If no such disclosure has been made, speaker warrants that no conflict of interest exists. Speakers must agree not to sell or promote any particular product or service at any time during the Program or Presentation.

AV NEEDS

Speakers with audiovisual needs are encouraged to provide their own equipment. If equipment is requested, every effort will be made to provide it. However, the Conference Committee cannot guarantee that the equipment will be available to the speaker.

SPEAKER EXPENSES

Sharing knowledge with other camp professionals is an honor and a privilege. Members have a mutual responsibility to share knowledge and advance our profession. Speakers at the 2007 Southeastern Camping Conference are on a pro bono basis. Those selected as speakers are able to register for the conference at the discounted student rate. Speakers that will only be attending their session do not have to register. All expenses for registration, travel, hotel accommodations, and meals will be at the speaker's expense unless a specific need has been identified and approved in writing from the ACA Southeastern Executive Director.
